18.4.1 Update 4 for Sage 300 Construction and Real Estate includes the following:

- 1. Exit all Sage 300 CRE Accounting applications.

- 3. Install the update on the Sage 300 CRE server and each workstation where Sage 300 CRE is installed.

- 4. Install the update on all machines where Sage 300 CRE Accounting is installed.
